- 1. Management and maintenance of PCHA-owned property (entry-sign and lot at Powhatan Crossing entrance, and the recreation lot on Powhatan Crossing).
- 2. Management and maintenance of the storm water system (swales, storm water pipes, and the storm water pond).
- 3. Enforcement of the Declaration of Restrictions (Covenants).

PCHA GETS 2018 GRANTS

For the third year in a row, JCC awarded matching fund grants to help HOA's complete projects to improve drainage, repair stormwater systems and improve water quality in county rivers and streams. Participation in the 2018 grant cycle increased substantially over that in 2017.

PCHA was awarded up to \$16,500 for three projects to be completed in 2018-2019:

- Camera inspection of our stormwater pipes (1,400 linear feet in Sections 3 & 4).
- Lining the pond's failing outflow pipe.
- Clearing and grading the pond's access easement.

As more HOA's use this program, competition for funds increases. With JCC's help, PCHA has achieved 2/3 of our restoration plan in less time and with greater fiscal efficiency than we imagined possible.

2017 STORMWATER WORK COMPLETE

With \$3,548 in <u>2017 JCC Drainage Matching funds</u>, PCHA began restoration of our stormwater system, some of which is more than 25 years old. Adding \$5,050 from our reserves to PCHA's matching share maximized the benefit provided by the County.

The following was completed in October by Longhill Excavating:

- Leaks through the pond's riser repaired.
- Debris removed from pond bottom.
- Erosion at the pond riser's base stabilized.
- Failed riser cover replaced.
- Access easement surveyed and marked.
- Pond's inflow pipes cleared.
- Trees blocking perimeter easement cleared.
- Eroded portions of pond perimeter reshaped.

For years PCHA struggled with how to manage the complexities and expense of our long-term stormwater system maintenance. JCC's Matching Funds program, born in part from discussions with HOA's such as ours, not only seeds HOA efforts but also lends the invaluable expertise of JCC's trained staff to help us design and execute the most cost-effective projects.

For \$8,597 from PCHA reserves, we accomplished what 5 years ago we thought would cost \$61,000!

Thanks goes as well to **Ron Feigenbaum** for managing ongoing Stormwater System work.

MORE ON STORMWATER

Annual work will continue:

- Keep easement around the pond clear.
- Cut back vegetation by the dam.
- Remove debris from pond.
- Assess system's other components.



- <u>**Trim**</u> curbs and gutters in front of your home - so runoff can drain properly.


STORMWATER DRIVES DUES

- Mapping our stormwater system in 2016 revealed <u>components</u> that had not previously been inventoried.
- PCHA's <u>5-year Strategic Plan</u> outlines immediate and mid-range operations and infrastructure expenses. It replaces our 2013 Reserve Study.
- JCC's Stormwater Matching Funds program led PCHA to build a multi-year restoration plan for our aging stormwater system.
- Raising annual dues incrementally over several years is needed to manage the restoration plan.
- The Board is obligated to set a dues amount to address the organization's needs (Bylaws, Art. VII, Sec. 2 (c) (1).
- Even after recent increases PCHA dues are among the lowest in the county.
